What is Management Contracting?

Management Contracting is a form of procurement where the Client employs various Subcontractors directly. The Client has a Main Contractor (the Management Contractor) who is responsible for facilitating the works and managing the Subcontractors, but the Management Contractor is not in contract with them directly.

On these projects, typically the client requires an Architect to undertake the design and remain in control throughout. However, with our Design and Build experience we often lead and co-ordinate the Design stage of the project.

With evolving project risks, a management contractor is a preferred route for our clients as they look to mitigate design and quality risks at, they have input into the selection of sub-contractors within the supply chain.

Given that a traditional Main Contracting procurement route means the Contractor has to include for risks, which would heavily inflate the price, Management Contracting is an intelligent way to avoid this. Also, because the Client is able to pursue each Subcontract Works package individually, they can ensure the best suitable trade contractor is selected for each package of work.

The process

Appointment

We begin by understanding your project and building requirements in detail, ensuring a solid foundation for the entire process.

Design Development

We collaborate and lead the process of the design. We do not hold responsibility for the design, but we actively involved to ensure the client requirements are met.

Construction

With the stewardship of our skilled management team the construction starts. We are responsible for managing the various Subcontractors and ensuring that they meet the programme, specification, and budgetary restrictions included within their Contracts with the Client.

Final Account and Handover
